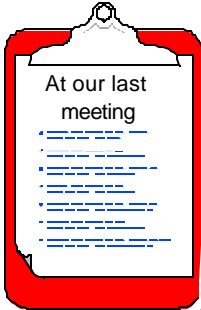

Our regular February meeting was called to order at 7:30 by our President, N4DOU, John Schumacher. All members and guests identified themselves, and we welcomed WA4OPL, Horace Beasley of Bishopville.

The repeater fund stands at \$3,275.33 as of 12/31/08. Interest in 2008 was \$10.54. Club membership stands at 58 with 4 lifetime and 54 dues paying. As of 1/31/09 39 members have paid their dues and we are waiting on 15. We had 28 at the January meeting with 22 members and 6 guests.

**ARRL SECTION & PIO:** In the absence of N4JJ, KO4L, LLOYD Mitchell reported that our own SC Emergency Coordinator, AE4UX, Charlie Miller has been awarded the 2008 Roanoke Division ARRL Service Award beating out five other candidates. Congratulations Charlie!

The ARRL has made an agreement with the FCC to allow groups within our organization to *volunteer* to help educate the public about the now delayed change to DTV. Interested groups or individuals should contact Pin Tech Corp who has contracted with the FCC to operate a help center in SC. SC Representative Ken Kennedy has introduced H3289 which pre-empts local zoning laws which do not make reasonable accommodation for Amateur Radio antennas. This new statute is similar to the PRB-1 law in NC and has been referred to the Labor, Commerce and Industry Committee. Members of that committee and the status of the bill can be found by searching [www.scstatehouse.gov](http://www.scstatehouse.gov). Our former member KI4AOQ, Ralph Thompson got this bill rolling.

Two bills, S0024 in the Senate and H3083 in the House, have been

introduced to restrict wireless communications by drivers of moving vehicles. These bills have the undesired effect of restricting the use of amateur radios in a moving vehicle which could seriously hamper our emergency communications abilities. Please contact your representative and senator to request an exemption for Amateur Radio and encourage your friends and relatives to do the same.

Lastly, the FCC has appointed Laura L. Smith of Pennsylvania as the Special Counsel for Spectrum Enforcement. She is an attorney but not an amateur. We will sorely miss K4ZDH, Reilly Hollingsworth, who retired last year.

**Emergency Communications:** KI4ORA, Jim Lavia, reported that he and Stacy Jones, the Red Cross Disaster Coordinator for the PeeDee have come to the following agreement:

"A representative of Florence Amateur Radio Club, who responds as a member of that organization (i.e. does not use Red Cross identification or clothing) will remain independent of the Red Cross in their support of the relief operations."

This means that FARC members would not have to submit to a financial background check. The club voted to have our President, N4DOU sign that agreement as soon as possible. There was a discussion about devising an identification card or badge for our members to use in lieu of Red Cross insignia in the case of an emergency. We may set up a committee at the next meeting to address this problem.
