The repeater fund stands at \$3,921.89. Club membership stands at 51 with 4 lifetime and 47 dues paying. We had 25 at the July meeting with 22 members and 3 guests.

**ARRL/PIO** N4JJ, Jack Jackson announced that our SC Section Manager, N2ZZ, Dr. Jim Boehner, had decided to run for the post of Assistant Director for the Roanoke Division in the election to be held in October. All ARRL members in the division will receive information directly from the ARRL about the voting

procedure. Dr. Jim has done an excellent job in SC and we hope that he will move up and continue his competent service to us.

**Emergency Communications:** KI4ORA, Jim Lavia, was not in attendance therefore no report.

**Repeaters:** All repeaters are healthy, however, K4AVR, Mac, reported that there had been a problem with the '85 which has been repaired. There has also been someone sitting on a microphone recently so please be more careful handling your mikes. Also there is a spare PA at the repeater location which was hidden behind some equipment but is now clearly marked and available should there be a problem in the future.

**Website:** There was a group discussion about things that need to be added to the website. We need to make sure that the information listed is current and to add an Application for Membership in FARC as well as some of our local ELMER information to include a list of volunteers willing to mentor new Hams.

N4DOU reported that the McLeod repeater is now on the air. He also distributed a list of the SCHEART analog repeaters which lists the locations, tone, power, antenna height and date on the air.

**Elmer Session:** In the absence of KO4L, Lloyd, we do not have a date or a location yet for our proposed session.

**Scholarship:** N4DOU read a letter from Sheryl Sheppard of Florence Darlington Tech concerning our scholarship there. We are still not clear about all of the details of this scholarship therefore the members voted to select a committee made up of KF4HJS, Dr. John Kirkland; N4MXP, Mark Davis; and W4ORW, Wayne Howell. This committee will get more information and report back. In the interim, we voted to send a letter to FDTTC requesting that no



new scholarship funds be disbursed from our funds until we contact them again and have a document listing all of the criteria for future distributions in writing. KJ4NKS, Chris Taylor, is on the local Boy Scout Council Board. He spoke about the Jamboree On The Air which is scheduled as always on the third weekend of October. He asked for our help and support. Several suggestions were made and we discussed possibly setting up a station at FDTTC. We will hear more at the next meeting.

At that point, KJ4NKS applied to become a member of FARC. We welcome him.

All FARC members were invited to attend the Annual Picnic of the PALS Net on Sunday, September 27 at Cheraw State Park.

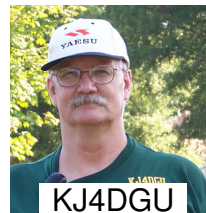
## Shelby Hamfest at Dallas, NC
